TERMS AND CONDITIONS:

1. The competition is being conducted by Burnside Village Pty Ltd, of 447 Portrush Road, Glenside SA 5065 ("Burnside Village").
2. Entry is open to all Burnside Village customers. Burnside Village employees, storeowners, retailers and their families are ineligible to enter. Solitaire Automotive Group employees are ineligible to enter.
